

PURCHASE LETTER OF INTENT

Purchase of LYGG Daily Services, routes from Mikkeli.

This purchase letter of intent (the “Letter of Intent”) represents the basic terms agreed upon by the Buyer and Seller. After this Letter of Intent has been made, a formal agreement may be constructed to the benefit of the Parties involved. With this Letter of Intent Buyer also informs LYGG of its wishes towards timetable’s and frequency. **For the sake of clarity this Letter of Intent does not bind either parties.**

I. The Buyer: _____ (the “Buyer”).

II. The Seller: LYGG (3167078-7) (the “Seller”).

III. The Service: The Buyer intends to purchase the following:

Service Description: LYGG Daily roundtrip service for the route’s as described below (the “Service”). The service includes the comfortability, flexibility and speed of private flights in a cost efficient manner.

All of LYGG’s flight operators are EASA (European Union Aviation Safety Agency) approved AOC’s (Air Operator Certificate) fulfilling the highest security standards. LYGG is a platform and does not own or operate the flights.

LYGG Daily Service proposes the following flight schedules:

- **Mikkeli – Stockholm**
Two days a week; morning and evening
- **Mikkeli – Riga**
Two days a week;; morning and evening
- **Mikkeli – Tampere**
Two days a week;; morning and evening
- **Mikkeli – Helsinki**
Two days a week;; morning and evening
- **Mikkeli – Tallinn**
Two days a week;; morning and evening

Additional flights and destinations are possible upon client requests and will be agreed upon separately. The timetables are preliminary and will be agreed before the start of operations, based on client feedback.

Purchase Price and Schedule:

The prices include the LYGG membership fees, air component, hand luggage, taxes and full compensation of the entire travel chain. Prices are valid for 12 months from the start of operations and signing of actual agreement. Tickets may be changed, cancelled and named travelers changed 24 hours prior to departure without extra costs.

V. Conditionality: The Buyer has been made aware that services described in Letter of Intent are conditional subject to the sufficient number of companies agreeing to same terms in the Mikkeli region.

VI. Purchase Amounts: The Buyer indicates in *Annex 1* requirements for services, schedule and routes needed.

VII. Acceptance: If you are agreeable to the terms, please sign and return a duplicate copy of this Letter of Intent by no later than 15 Mar 2023.

LYGG SERIAL

- A company specific serial ticket for selected route, more affordable and suitable for regular traveler
- Can be booked through LYGG App or Web portal (Coming Q2/2023)
- Price depends on volumes
- Best for companies that have regular travel on a specific route for more than 10 one way trips per month
- Non-named tickets can be allocated by the Buyer as needed

LYGG FIXED

- A company-specific seat for a specific route flight for a specific day for permanent need
- Can be booked through LYGG App or Web portal (Coming Q2/2023)
